## Council response:

Stop no# 2036119 Anzac Pde after Pine Street. South bound.

Council has identified this location as a priority for a bus shelter due to its proximity to the assisted living facility. The idea of relocating a shelter was explored by Council officers recently. There is a significant risk of damage to the shelter in this process and cost incurred and therefore not feasible.

The current commercial contract for shelter supply is nearing its end and the third-party supplier is not willing to incur cost by relocating or installing a new shelter.

Council officers have been instructed to explore the possibility of a non-advertising shelter being installed at this location.
