4. Alfresco Randwick Program On-Road Activation for site 76 Clovelly Road, Randwick NSW 2031

The program for this site has been discussed at the meeting and various concerns have been raised by residents about the suitability of the site for this program.

Concerns centre around cars turning left into St Marks Rd at speed with limited visibility which will be further impeded by the on-road dining area, endangering the diners, pedestrians and cyclists. The current business already occupies a large portion of the footpath on St Marks Rd and the proposal will make the footpath even narrower and less safe for pedestrians. Concern has also been raised that due process has not been followed, with the resident notification period starting on 29 April 2025 but the notification letter to the residents dated 1 May 2025 was not received until 5 May, effectively losing almost 1 week of notification period.

Motion 07052025(1): Randwick Precinct requests that the Randwick Council does not proceed with the on-road activation of 76 Clovelly Road, Randwick site due to the serious safety concerns and increased pedestrian congestion. Randwick Council to consider additional outdoor dining spaces on adjacent Clovelly Road footpath as an alternative.

Randwick Council to extend the consultation period to 22 May to account for the late notification.

5. The footpath through Bob's Garden is unlit and is unsafe for pedestrians during the evening and nighttime, especially during the winter months. Pedestrians are using mobile flashlights to navigate through, which is not ideal (tripping hazards etc). Some suitable lights during the high pedestrian traffic time is required

Motion 07052025(2): Randwick Council to urgently install lights along the footpath through Bob's Garden

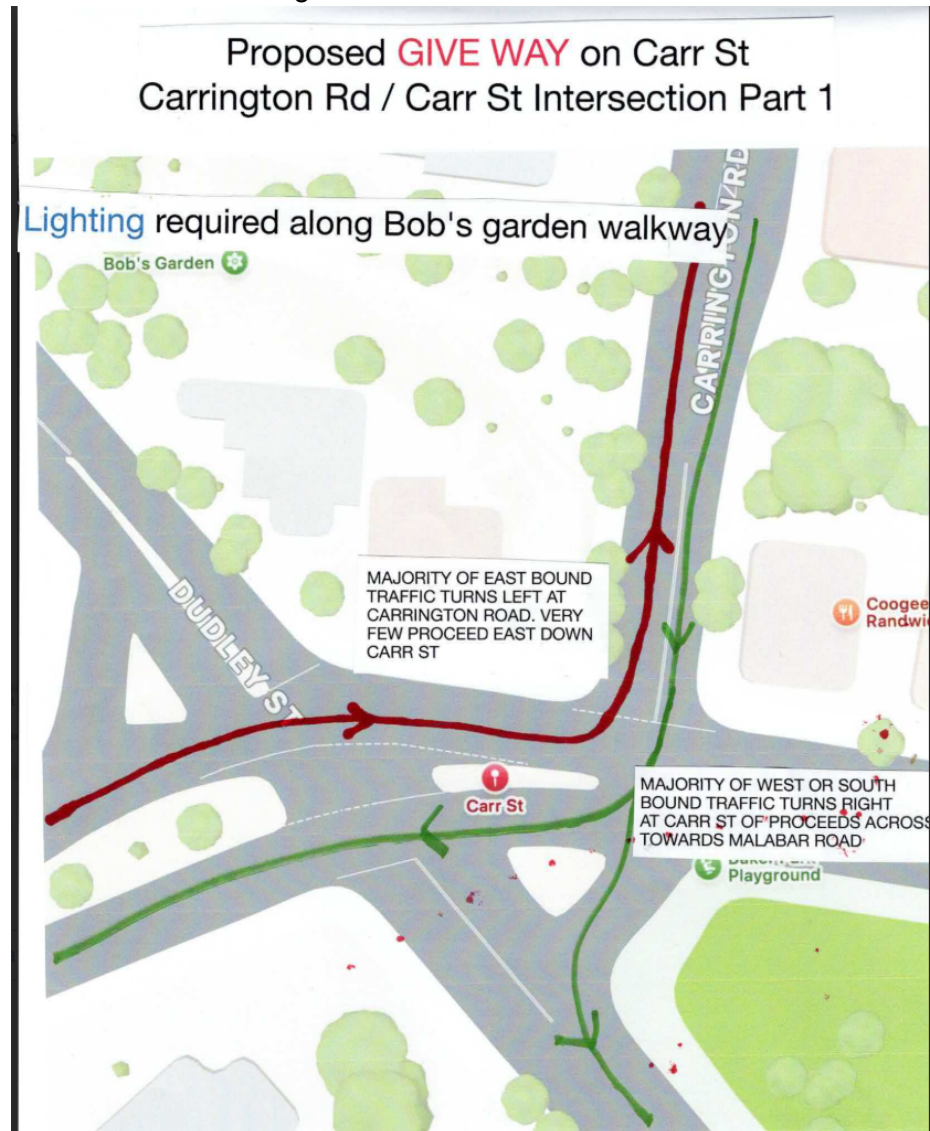
6. The intersection of Carr St and Carrington Rd is a major traffic hazard issue due to its topography (steep hill) and layout. There are significant delays as drivers navigate the intersection, particularly southbound from Carrington Rd.

Motion 07052025(3): Randwick Council to investigate the installation of a Give Way sign on Carr St where it intersects with Carrington Rd as a possible solution to traffic congestion on this major intersection.

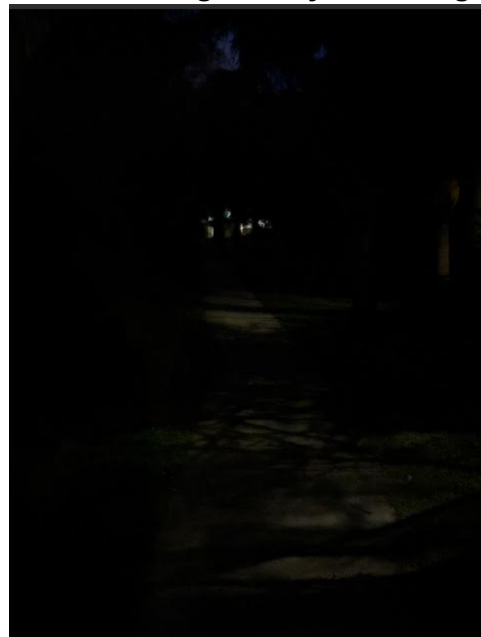
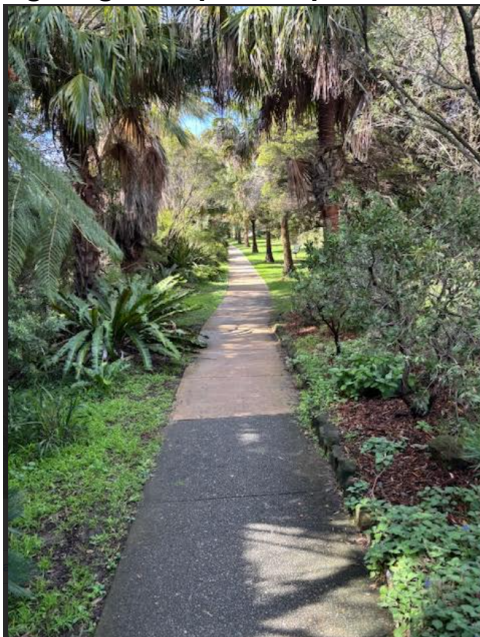
