Dear Coogee precinct committee,, Thank you for your correspondence to Council about the towing of vehicles obstructing access to private residences. I appreciate you raising your concerns., Rule 198 of the Road Rules 2014 provides that it is an offence for a driver who stops in a manner that obstructs access to and from a footpath or driveway. The offence attracts a minimum penalty fine of \$320. If the offence is committed in an operating school zone, the fine increases to \$410 and the allocation of 2 demerit points., I note that there are also a number of provisions under road transport law that provide for the removal of a motor vehicle from a road or road related area by NSW Police or Council Officers. However, these provisions are intentionally and appropriately limited to removing vehicles that are causing a danger or an obstruction to traffic in prescribed places such as bus lanes, clearways, T-Ways, transit lanes, and freeways., The Public Spaces (Unattended Property) Act 2021 (the PSUP Act) came into force in November 2022 to help protect public spaces from abandoned and unattended items including vehicles., The PSUP Act adequately empowers Local Council Officers to take enforcement action and move unattended or abandoned vehicles that restrict access from a residential driveway to a public place, provided the vehicle has been left in a public place. In order to do so however, Council must be satisfied that the vehicle is unattended. In practice this means making reasonable enquiries, including with NSW Police to contact the registered owner of the vehicle and advising them that the vehicle is causing an obstruction and needs to be moved., In the case of a complete obstruction and where the owner fails to take action or Council/NSW Police is unable to contact the owner, Council may begin to make arrangements to have the vehicle relocated to the closest available legal parking space. As Council does not own or operate tow trucks, we are reliant on the resourcing and availability of our approved contractors to facilitate this. In some instances, this may take 24 hours. Council will not currently consider removing vehicles where access and egress to a property are still viable and we are still actively making attempts to notify the registered owner., Thank you again for your enquiry and should you require further information, please do not hesitate to contact me.

The owner is aware of both the Council resolution (of the Council Meeting on 25/02/2025), and the strong community interest in protecting this property. At the time, the owners advised that they would contact Council to arrange a site meeting to discuss these options and the application of heritage requirements for any alterations. We have not heard back from them regarding this offer., Following the Council resolution, we notified Council's Customer Services to monitor for any Complying Development Certificate (CDC) applications for this address that may affect the property. To date, no CDC applications have been lodged. We have also regularly checked that no Development Application (DA) has been lodged for the subject property. To date, no DA has been lodged for the property. , We have also sent a follow-up email to the owner seeking an update on any concept plans and reiterating our offer to meet on-site., In line with the Council resolution, the property at 128 Mount Street, Coogee, is included in an upcoming heritage study, which will assess the heritage significance of a range of properties in the Randwick LGA including those not recommended for listing in the 2020 heritage study and review areas impacted by the State Government's Low and Mid Rise reforms announced in February. A brief has been issued to selected consultants requesting quotes for this work which Council is currently assessing. A Council report is expected by the mid 2026, recommending properties to progress as draft heritage items for public exhibition. Meanwhile, Council officers will monitor for any CDC or DA that may be lodged for 128 Mount Street, Coogee, so that appropriate action can be taken to protect the property.</p>
