There was considerable discussion Resolution 28/24: That the Precinct further object to DA985/2024 due to the proposed height and FSR, the loss of mature Phoenix Palms on site and the threat to mature paperbark and fiddle-leaf trees next door (both outcomes resulting in loss of habitat), and the inappropriateness of building a holiday rental opposite a school when affordable housing for local workers and their families was in such demand 8.10 CBA building. The previous Chair (Mark) reported that the building will now be included as a heritage item in the next LEP. The matter had gone to Council. It was thought it would just go through but a legal representative for the owner opposed it. Mark spoke for it and, despite some Councillors' opposition, it was approved.
