## Resolution:

Resolution 22052023(3): Council is requested to open the Recycling Centre in Perry St each Saturday and to reinstall the green waste service.

---

## Council response:

Council's Perry Street Recycling Centre is open Monday to Friday and on the first Saturday of each month. We are currently conducting a review of the services and operations for the Centre including operating times and services that we provide and will publicise changes to this service as they occur.

The Greenwaste drop off service that was provided at the Perry Street Recycling Centre on Saturdays was limited to residents that were able to transport their excess greenwaste to Perry Street. This service was labour intensive with several staff being rostered overtime each Saturday to facilitate a limited number of residents that were able to transport their excess greenwaste to the centre. Staff also had some difficulty in restricting the service to residential ratepayers.

By providing a kerbside collection of bulky and excess greenwaste, all residents can utilise this service at their convenience regardless of transport restrictions.

Council collect bulky greenwaste that has been tied into manageable bundles from residents kerbside, This service operates in conjunction with the general and whitegoods collections and can be booked using <https://www.randwick.nsw.gov.au/services/rubbish-and-recycling/book-a-clean-upform> at a date and time that is convenient to the resident up to Five times per year, subject to booking availability. Residents can also book by contacting Council's Call Centre on 1300 722 542 during business hours.

## Resolution:

Resolution 22052023(6): In relation to Lasseter Avenue, Council is requested to renew lane/ traffic control markings and replace missing No Standing signs.

Background/meeting notes: Lasseter Ave Safety Item. There is poor visibility of oncoming traffic due to the undulating road at the top the hill. The double lines have faded and the no standing signs have been removed, perhaps illegally.

## Council response:

An instruction has been issued to re-mark the partially worn centrelines along Lasseter Avenue, from Little Bay Road to near no.64. Our contractor gathers a number of linemarking projects tasks together and undertakes them over a few days. Accordingly, this work may take up to 8 weeks to complete.

Unfortunately, we have found no record of any Lasseter Avenue No Standing signs. In order for us to undertake a better search is the Precinct able to inform me as to exactly where these signs previously existed?

Resolution 22052023(7): Increase green maintenance along Bunnerong Road (between Military Rd and Little Bay Rd). Issues are an abundance of weeds; plants along the road have mostly died and trees need maintenance.

## Council response:

Council staff have inspected the road verges and associated open space between Military Road and Little Bay Road. The garden beds between the footpath and the road verge are kept weed free, however, there are plants missing along this section. In addition, on the western (bushland) side of the footpath and at the north-western corner of Bunnerong Road and Military Road, minimal work has been undertaken. Council will work to make improvements in these areas over the next three months.
