Resolution	Campaign to upgrade Henry Head Lane and Cape Banks Road. Peter Fagan delivered a presentation entitled <i>"Henry Head Lane – Cape Banks Road: Sydney's worst public roads?"</i>. Peter spoke about, and illustrated with photographs, the significant deficiencies of both roads, their importance to the community, the risks they posed for pedestrians, cyclists and vehicles alike and what can be done to fix the problem. A resolution was proposed by Peter: Bays & Beaches Precinct considers a complete reconstruction of Henry Head Lane and Cape Banks Road is necessary, to address the needs, amenity and safety of the many users of these roads. The Precinct will seek engagement with key stakeholders to begin the process of designing and constructing a new road that meets the needs, amenity and safety of the many users of these roads. Update on Resolutions	Brick debris washing down onto Little Bay Beach (Res # 1, 19/06/24 mtg) Peter Fagan, who proposed the resolution, confirmed there was no further update. Councillor Noel D'Souza undertook to follow up on the issue and advise the Precinct. Parking of RVs, boats, trailers and vehicles (Res #4, 17/04/24 mtg) Council advised that a report on parking along the central reserve of Anzac Parade is proposed to be tabled at an upcoming Council Meeting. Councillor Noel D'Souza undertook to follow up and advise the Precinct of developments.
General Business	Community consultation for EV chargers The Chair referred the meeting to a joint Waverley and Randwick Council "Have your say" on the proposed initiative to instal EV charges in both local government areas. For the 2nd round of consultation, 15 locations are proposed in the Randwick LGA. These include a range of street pole chargers, ground mounted chargers, and fast chargers.
