Randwick Council has issued the following development consents.

CLOVELLY

DA/1076/2024, **23 Northumberland Street**: Alterations and additions to an existing semi-detached dwelling including construction of a first floor addition, lower ground floor with rumpus room, bathroom and plant/equipment storage, installation of a new swimming pool and double car garage at the rear, associated ancillary and landscaping works.

COOGEE

DA/83/2025, **56 Ritchard Avenue:** Alterations and additions to the existing dwelling including new gym room and decking at basement level, with roof terrace above, and minor internal reconfiguration.

KINGSFORD

DA/1254/2024, **28 Bass Street:** Minor demolition works to remove the existing carport, the small front awning and front door to enable the enclosure of the existing front porch to create a larger bedroom with walk-in robe and ensuite and the construction of a new carport.

DA/290/2022/A, **25 Jellicoe Avenue:** Section 4.55(2) - Modification to the approved development for internal reconfiguration of ground and first floor level, amendment of external doors, balcony and glazing, minor rear extension works to both levels and the addition of an outdoor seating and BBQ area.

DA/272/2024/B, **117 Cottenham Avenue:** Section 4.55(1A) Modification to the approved development to amend Condition 1 to refer to revised BASIX Certificate. Original Consent: Demolition of existing buildings and construction of a 2-storey dwelling house and swimming pool, ancillary and landscaping works

DA/1127/2024, **6 Hinkler Street:** Alterations and additions to existing semi-detached dwelling, including rear extension at ground floor level and new first floor addition.

DA/1139/2024, **9 First Avenue:** Alterations and additions to existing dwelling, including new lower ground floor, rear ground floor extension, two new rear balconies at ground and first floors, and a car lift.

MATRAVILLE

DA/1200/2024, **3-19 Military Road**: Alterations to an existing waste transfer station and material recovery facility involving the receipt of food and garden organics (FOGO) waste, with no changes to site operations, truck movements or physical changes to existing infrastructure.
