Resolution 25022025(3): The Maroubra Precinct Committee calls on Randwick City Council to consider the merit of (a) installing CCTV cameras in both Coral Sea Park and Pioneer Park and (b) installing signage banning the use of motorised bikes (petrol and e-powered) in both these parks and perhaps all parks within Randwick City jurisdiction.

Council response

Randwick City Council is currently liaising with NSW Police Eastern Beaches Crime Prevention Unit regarding the Precinct Committee's request for the installation of CCTV in both Coral Sea Park and Pioneer Park.

Randwick City Council will consider the installation of CCTV when the request is endorsed by NSW Police and where there is a significant public interest and is supported by a well documented incident history in that specific location.

The precincts request for additional signage at these locations, specifically with regard to motorised bikes has been forwarded to Councils Technical Services department for actioning.

Resolution 25022025(4): The Maroubra Precinct Committee calls on Randwick City Council to investigate the legalities of the fireworks events regularly conducted by Horizons / Sth Maroubra Surf club on weekend evenings. Who is responsible for these activities and are there licences required to use fireworks in a public place and any safety protocol requirements. There are also concerns with environmental pollution of the beach and parkland and the risk of fire in adjoining bushland and the noise impacts on families with young children and pets.

Response

Fireworks in NSW are regulated by SafeWork NSW and there is a requirement for pyrotechnicians to notify SafeWork NSW, Council, NSW Police and NSW Fire and Rescue about all fireworks displays.

In addition, prior to conducting fireworks displays from within a public space like the beach, the relevant person (i.e the operator of the associated business) must obtain approval from Council's Open Spaces team via the lodgement of a Public Space Hire Application.

I also advise that Horizons have previously obtained approvals for this activity and any approvals are also subject to compliance with NSW SafeWork requirements.

Should anyone have any concerns about a specific incident, they are welcome to refer their concerns to Council for consideration and any appropriate action.

Any concerns about safety matters from the use of fireworks may also be referred directly to SafeWork NSW for their consideration.

Response

- Liaise with our Communications team to prepare an education piece and awareness initiative for lawn mowing contractors and residents.
- Potential enforcement action to prevent improper disposal.
