Council response:

Normally, our Urban Forest Planner would attend the Precinct Committee meeting to provide an update on our Greening Randwick initiatives. Unfortunately, the role has been vacant. On this basis, a representative has not been available to attend the precinct committee meeting.

However, an update on our initiatives is provided below.

- Greening our City Grant - \$1.88M – Planting of 2,000 Trees to commence in March 2024. Planting will be targeted in the south of the LGA where canopy cover is lowest.
- We propose to develop a Green Grid Strategy in line with the NSW Strategy
- Planting of 500 trees from council's budget. These trees will be planted in town centres, open spaces and streets.

Council response:

Council Tree Preservation and Maintenance Officer organised a site visit on 23/06/23 to assess the condition of the Banksia Integrifolia located at the corner of Keith St and Clovelly Rd, Clovelly.

Inspection confirmed that the tree was dead and to be removed. A work order has been issued to one of Council's contractor for removal of the tree. Works were completed on 17/07/23 and tree is now removed.
