Resolution:

Resolution 12022024(4) – Precinct would like to know council policy on dog attacks in LGA, in regards to actions and responsibilities for handling the situation.

Council response:

Randwick City Council understands the severity and urgency of dog attack incidents and is committed to ensuring the safety and well-being of all our residents and their pets.

Please be informed that our Council Rangers are authorised under the Companion Animals Act 1998 (The Act) to investigate reports of dog attacks throughout the LGA. This authority encompasses potential offences under sections 16 and 17 of the Act, which relate to the responsibilities of dog owners and the actions required when a dog attacks a person or another animal.

When a dog attack is reported to Council, Rangers will conduct a thorough investigation, which may include interviewing witnesses, gathering evidence such as photos and medical records, and assessing the circumstances surrounding the incident. It also includes checking the Office of Local Government databases to determine whether the identified dog has been found to be responsible for previous attacks.

Depending on the outcome of the investigation, there may be a number of actions that may be taken, which could include, but are not limited to, issuing warnings, imposing fines, or declaring a dog to be dangerous or menacing. These measures are in place to prevent future incidents and to hold pet owners accountable for their animals' behaviour.

Under Section 18 of the Act an authorised Council officers also has the power to secure or seize an attacking dog in the immediate 72 hours following an attack. As this intervention is quite severe, it is usually reserved for more serious incidents or where it is determined that the dog presents an ongoing risk to the community.

All confirmed dog attack incidents are recorded against the applicable dogs microchip number in the Office of Local Governments Companion Animals Register.

Council takes all reports of dog attacks seriously and encourages residents to report any incidents to the Council as soon as possible, providing as much detail as they can. This enables us to respond effectively and take appropriate actions to mitigate risks and ensure public safety.

Resolution:

Resolution 1202024(5) – Council to look at the traffic congestion at Paterson St and Hunter Ave during school zone, number of cars trying to use these streets are causing hazards. Precinct members happy to meet with council on site to discuss congestion and dangerous situations.

Council response:

The traffic survey data for Hunter Avenue was submitted to the June Local Traffic Committee meeting which was held on 11 June 2024. The minutes of this meeting are posted on Council's website via this link - <https://www.randwick.nsw.gov.au/about-us/council-and-councillors/council-meetings/business-papers-and-minutes>.

The traffic data showed that whilst the data reflected the peak flows of the nearby school due to pick-up and drop-off activities, the traffic volumes along Hunter Avenue are not greatly skewed in the eastbound or westbound direction. Between 9am and 3pm, 60% of the average weekday traffic volumes along Hunter Avenue travelled eastbound and 40% travelled westbound. Similarly, between 4pm and 9pm, 61% of the average weekday traffic volumes travelled eastbound and 39% travelled westbound.

The data highlighted that the average daily traffic volumes are typical of such locations and the 85th percentile is 39.1km/h which is well below the posted speed limit of 50km/h.

Consideration was given to restricting Hunter Avenue to one-way flow; however it would have an impact on traffic flow in the locality and access to both residential and commercial properties in the vicinity of the site. When considering the traffic flows outside of the school peak period, these are not considered significant enough to warrant a one-way treatment. In addition, the data shows that vehicles are currently travelling well below the posted speed limit.

As with any road network surrounding a school, a greater volume of traffic is expected for a short period of time due to school pick up and drop off. The requirement for vehicles to yield to one another on the road works to create a lower speed environment.

Hence the recommendation of the meeting was that the results of the traffic surveys be noted and that the Precinct be notified about the recommendation of the Traffic Committee.

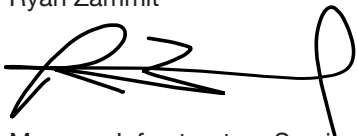
Resolution 120202024(9) – Purcell Park – council to examine the garden beds on Western side of the park, weeds and fallen debris from branches making park look very untidy.

Resolution:

Resolution 12022024(12) – Council investigate placing a no U-Turn sign on Bunnerong Road heading north in front of Australia Ave. Cars heading north at the break in the median st are doing U-Turns. If trying to turn right in Australia Ave from Bunnerong Road, unable to see all lanes clearly heading north on Bunnerong Road. Accident will happen!

Council response:

From a road safety perspective, the most recently available five years of crash data reveals that there has only been a single reported crash at the Bunnerong Road / Australia Avenue intersection. This single vehicle crash, which occurred around 9:30pm on 5 March 2019, involved a northbound car running off the road to the left, into a parked car or other object.

Given the significant volume of motor vehicles travelling through this intersection every day and given the single collision recorded over a period of 5 years, this site can be considered as performing very safely.

However, as Bunnerong Road is a State Road under the control and management of Transport for NSW (TfNSW), the final decision on this matter would need to be determined by TfNSW. Would the Precinct please confirm that referral of this matter to TfNSW, by Council Officers, is endorsed?
