1.	Malabar Outdoor Movie Night or Weekend (1 or 2 nights) (Deferred to January Mtg due to time) There is a suggestion to approach Randwick City Council under the community cultural program to create a "Malabar Movie Night" during the Summer Season to be held in Pioneer Park, as an annual community event. Initial investigations have suggested the cost of a reasonable outdoor screen, audio and staging staff to cost Est \$6000.00 The movie selection could follow a theme, new release or be associated with an event? 2.	Bike Pump Park – Alternate Location An alternate location is nominated as a result of the November resolution from the Precinct to oppose Cromwell Park as the location for the proposed Pump Park, but not opposed to the Pump Park in an alternate location. The Chair is proposing a possible alternate to move the Pump Park location to Upper Pioneer in the area adjacent to the AFL/Cricket toilet block, the location is currently supposed to be the designated off leash zone however almost all off-leash dog exercise takes place on field 4 The Off-Leash dog zone be moved to the Upper section of Cromwell Park which is the "construction" exclusion zone identified by Sydney Water (a swap), this will also keep the active dogs away from the active people and is easier to manage all user groups needs. Discussion Summary There was robust discussion from the community on the Pump Track status, members are not opposed to a Pump track but there is a division in the community on using Cromwell Park. Members for the use of Cromwell park have sighted the tree canopy and shaded area along with the topography of the park as benefits but the main concern is additional delays with any change to location, they have asked for a status of the project urgently, sharing of design and a commitment from council. Members opposed to using Cromwell are still in the majority and have restated that Cromwell should be retained as a low impact recreation zone as outlined in the November minutes.

Both groups still support the concept of the Pump Track but are divided on Cromwell Park as the location, the Chair covered the alternative and both groups can see the merit and are generally supportive except in the even of further delays on a final outcome.

Resolution - MAL20250122-B

That Council expedites the project and commences a period of consultation by the end of March 2025 as follows:

- a) On the proposed location Cromwell Park noting the absence of any previous consultation
- b) On the Alternate location Upper Pioneer v Cromwell Park
- c) If available the revised concept design for Cromwell Park so that the community can evaluate

It is **noted** that the Chair requests a council representative to attend the March meeting to brief the members of the status.

	Floor Items Plan of Management – Lack of action (K Gordon) K Gordon who is a local resident and member of the BushCare volunteer community has noted the lack of engagement and action on the Plan of Management for Malabar by Council. The Chair noted the update from Council that the POM for Malabar is prioritized behind other precincts and is not possible to review before 2027 given the resource requirements to undertake such a review.	
	At the general Council meeting held on the 26 th November 2024 motion NM87/24 was passed and #5 of that motion was to expedite the review of Malabar's Plan of Management.	
4.	An update from Council on 17 th Jan 2025 that the current list of POMS for review over the next 5 years are Maroubra Beach, Coogee & Clovelly, this would indicate that Malabar is not even on the list within the next 5 years.	
	The Chair highlighted that this was first raised with Council in 2020 in a meeting with then GM Therese Manns and T Clarke, the Precinct was advised that when a review program starts Malabar would be considered as a Pilot precinct, this has not eventuated.	
	It now seems as though Malabar will not be addressed before 2030 which is totally unacceptable to the local community.
