Could council please investigate if the lights are not working.

Council response

A night inspection of all the solar lighting along the paths within Barwon Park has been scheduled to identify lights that are not working. The inspection will be undertaken within the next 2 weeks.

Any lights that are not working will be referred to our maintenance team to arrange the replacement of the lamp, battery or solar panel. Due to the nature of the stated repairs and the requirement for parts, the repairs may take 4-6 weeks.
