A site inspection was undertaken by one of Council's Transport Engineers. In regard to the

parking issue at the southern end of Byrd Avenue, Council supports the removal of parking by installing 10-metre statutory No Stopping signs at both the southern and northern ends of Byrd Avenue., Council has also investigated the feasibility of converting Byrd Avenue to a one-way street in late October 2024. To better understand existing traffic conditions, a seven-day traffic count was conducted between Sturt Street and Anzac Parade. The data indicated that, on weekdays, approximately 65% of traffic travels southbound and 35% northbound., Based on these results, converting Byrd Avenue to a one-way southbound would require diverting 35% of existing traffic to the surrounding road network. Conversely, a one-way northbound configuration would divert approximately 65% of the total traffic volume. In both cases, the resulting traffic diversion is expected to adversely affect the performance of the surrounding road network., Accordingly, Council does not support converting Byrd Avenue to a one-way road in either direction.
