5. Matters Arising:

We are waiting on a response to our resolution requesting Council to provide the funding as identified in the **Carry Over Schedule 2024-2025**, to commence the Clovelly Bay Master Plan, without delay.

6. Action Sheet update:

The committee has received updates on a number of resolutions put to it from previous meetings. They will be sent out with the minutes.

Gordons Bay Steps: One outstanding resolution that Edwin Osbourne was very keen to inquire after was the provision of a rail for the steps in Gordons Bay. The response recently received is:

The Gordons Bay Steps railing upgrade, the paint renewal works, along with further works to the Coastal Walkway are planned for winter of 2026.

Bike track for Burnie Park: On the resolution that a bike track be built in Burnie Park the following response was received:

The Coordinator of Open space Assets has assessed Burnie Park and confirmed a bike track is feasible. Council is proposing a full playspace upgrade, including a basketball court (to complement the existing hoop), a new playground, bike track and hall. Planning is about to commence for a staged rollout, as funding is currently available for most but not all elements. To ensure future upgrades are not compromised, works will be carefully staged: basketball court, playground, bike track, and finally the hall. This staging aligns with the current budget, and all updates will be brought to the committee and public prior to any works.

7. Correspondence Incoming and Outgoing Incoming:

7.1 Council Notice.

The Council notified the community that Clare Willington has been appointed as Deputy Mayor for 12months.

The Precinct Committee congratulated Clare on a well-deserved electoral result.

7.2 Local Transport Forum.

The agenda for the Local Transport Forum of October 8th indicated the following:

No. TI1/25 Subject: Boundary Street, Clovelly - Parking Restriction (C) **Background:**

Council has received feedback from residents of Boundary Street regarding the long-term parking of trailers and boats along the railing adjacent to the Waverley Council Cemetery wall. This area has become a frequent location for extended trailer and boat parking, prompting concerns about reduced road width adjacent to trailers parked parallel to the railing.

Proposal

To discourage long-term parking, it is proposed to implement a "No Parking 7am-7pm Wednesday, Motor Vehicles Excepted" restriction along approximately 144 metres of the northern side of Boundary Street, from opposite No. 95 to the eastern edge of the driveway for No. 76. This signage will enable enforcement by Council Rangers once a week, requiring trailer and boat owners to relocate their vehicles regularly and thereby reducing extended occupancy of the space.

Recommendation That the "No Parking 7am-7pm Wednesday, Motor Vehicles Excepted" signage is received for installation for the northern side

of Boundary Street from opposite No. 95 Boundary Street to the eastern edge of the driveway for No.76 Boundary Street.

Paint in Clovelly Bay

A committee member contacted the chairman concerned about the impact of the current pool renovation on the environment of Clovelly Bay. During her morning swim she was alarmed to see many blue paint chips on the bottom of the bay.

It does not appear that sufficient environmental measures have been implemented to minimise the impact on the bay.

It has been observed by other members of the committee that the blue pain flecks have often appeared after the regular cleaning of the pool.

That immediate action be taken to ensure no paint or any other deleterious material is deposited in the bay to eliminate any damage being caused by the pool renovation.
