Resolution 13032023(2): That the Council Bushland Team consider whether there is any scope for expansion of the bushland conservation area at Burrows Park.

Council response:

Council's Bushland team currently maintain a variety of areas in Burrows Park. These areas include the fenced remnant bushland east of the playing field and numerous areas of reconstructed natural vegetation in the north of the park adjacent to the coastal walk and areas to the south of the playing field extending west around Clovelly Bay.

The remnant area east of the playing field is surrounded by rocky outcrops, which is not practical to expand. The remaining areas of reconstructed natural vegetation are continually expanded by Council's Bushland team. This is a gradual process that involves expansion by planting when and where opportunities exist.
