Case study where the existing DA notification process has failed is DA/485/2024 12 Heath St, Randwick (Claremont College). The properties requiring notification should have included both sides of Judge St, as all traffic for the proposed DA is directed to Judge St school drop-off zone - yet most dwellings were excluded from the notification process, despite being significantly impacted by any increase in school operating capacity.
