Resolution 13052024(1) - That in line with the General Manager's proposal for the Council officers to be more active in improving the customer experience with the community, that he enables the request for access to the Peer Review of the Clovelly Flood Catchment Study (CFCS) to be available publicly to allow residents at least one month to review the report and make enquiries prior to consideration by Council.

Council response:

Further community consultation will be conducted in the CFCS. Council's Drainage Engineer has reappointed the technical expert to recommence investigative works to identify any potential mitigation measures with the intention of reducing flood impacts. Once this exercise has been complete Council will assess the recommendations and will advise the community of the outcome.

Resolution 13052024(2): The Precinct Committee noted Council's response to Resolution 19022024(1) regarding documentation relating to the lengthening of Burrows Park football field. In particular the Committee noted Council's statement that at a meeting it facilitated in October 2023 and chaired by Ray Brownlee, Council General Manager, all the sports field users attending the meeting "voted in favour of pursuing further investigations into a full-size field ...".

The Precinct Committee requests that Council confirm that the position supported by the clubs regarding the extension of the field as expressed at this meeting was as follows:

- o the field is lengthened by 3 to 4 metres, requiring no major earthworks.
- the width of the field go to 68m wide which will involve moving the lights a few meters to west and east when the new facility is built
- o no requirement for either a grandstand, a score board or parking

The Precinct Committee requests it be provided with any documentation Council has of this October 2023 meeting and in particular documentation in regard to a proposal and vote at this meeting to pursue "...further investigations into a full-size field..." at Burrows Park.

Council response:

As per the resolution of Council at its ordinary meeting in November 2023, Council Officers have commenced a master planning exercise to determine the feasibility of a larger field. Sporting clubs were in support of master planning for a full-size field that caters for ages 13 and over. Clubs would like the extension of the field if possible, and to have a least impact on the surrounding environment as possible.

It is expected that the community consultation will commence in February 2025. Given Council election period, the Masterplan will be reported to Council in November 2024 and Council under our community consultation policy does not conduct consultation over December.

I can be confirmed that the master planning exercise is not considering a grandstand, a score board or parking.

Resolution 13052024(3) – Has the cost of the scope of work for the for the development of the Burrows Park masterplan increased from its budgeted \$250,000 and if so by how much?

Council response:

FY2022/23 \$250,000 Allocated for Planning and Design Works of Burrows Park

FY2023/24 \$500,000 "top up" funding allocated for Planning, Design and future

construction of the project whether it is building and field or just building

alone

FY2024/25 \$500,000 "top up" funding allocated for future construction of the project

whether it is building and field or just building alone

By way of funding strategy, a "top up" will be recommended to Council year on year until the project budget matches the project cost which will be determined in the master planning exercise. As noted above whether the building is simply constructed only, (i.e. no field works) the project will still be in the millions.

The cost of the "Lead Design Consultant" after publicly testing the market in the line with the above mentioned "request for quotation was of \$414,870.00 + GST
