Updates on Precinct Resolutions	Parking of RVs, boats, trailers and vehicles (Res #4, 17/04/24 mtg)  In April 2024, the precinct passed a resolution for Council to provide the community with a concept plan for the introduction of designated areas and/or permit controlled parking for the Anzac Parade median strips at the following locations:  1. Jennifer Street to Reservoir Street 2. Bilga Crescent to Solarch Avenue 3. Kain Avenue to Franklin Street
	Subsequently at the Ordinary Council meeting of 26 November 2024, Director City Services tabled Report No. CS50/24 Subject: Investigation - Uncontrolled parking of various types of RVs, trailers, vehicles and boats on Anzac Parade.  This report can be found on pages 26-33 of the Agenda for Ordinary Council meeting of 26 November 2024: https://randwick.infocouncil.biz/Open/2024/11/OC_26112024_AGN_3694_AT.PDF  A motion (NM3/25) was raised by Councillors Danny Said and Bill Burst at Randwick City Council Ordinary Meeting dated 25 February 2025 to include in Council's proposal to TfNSW the option of defined parking area on Anzac Parade median off Budd Ave, Little Bay for 60 spaces, a defined parking area on Anzac Parade median off Bilga Crescent, Malabar for 24 spaces, and parallel parking on the Anzac Parade median between Kain Avenue and Hillary Parade for 16 spaces for passenger vehicles only;. This motion was defeated.

The Precinct reiterated its original resolution that any proposed solutions to resolve the problem should first be communicated to the Precinct and the community for residents to consider and respond with feedback.

#### Removal of foliage at Bunnerong Road/Little Bay Road roundabout (Res #1, 27/11/24 meeting)

A resolution was passed at the Precinct's meeting on 27 November 2024 for Randwick City Council investigate, as a matter of urgency, the reduction in height or removal of vegetation on the south side of Little Bay Road in the vicinity of the Bunnerong Road roundabout — to improve visibility for vehicles northbound on Bunnerong Road.

Council's engineers have inspected the approaches to this roundabout and found visibility to be adequate. Council's report is attached.

However, Councillor D'Souza undertook to request Council to expedite the Land & Engineering Survey into the roundabout's approaches scheduled for completion by June 2026.

#### Improvement of public access roads to Kamay Botany Bay National Park Res#1 16/10/24)

Letters from our local member, Michael Daley and Minister Penny Sharp, Minister for Environment and Heritage responding to the resolution, are attached.

The letters reiterate that a resolution to this issue will need action from all levels of government and relevant private sector entities. Minister Sharpe suggested that the Precinct contact NPWS to progress the matter. Chris will contact Ben Khan, Manager South Sydney Area, NPWS and report back next meeting.

## Presentation and Resolution #1

A presentation by Peter Fagan "Disintegration of the Yarra Bay Groyne and need for urgent action" is attached.

In response, the Precinct passed the following resolution:

Bays and Beaches Precinct recognises that the continuing deterioration of the groyne in Yarra Bay at Yarra Bay 16 Foot Sailing Club poses extreme risks for the sailing club (damage to built assets) and for swimmers and surfers on Yarra Bay beach in the vicinity of the debris from the damaged groyne.

The Precinct notes that the responsible authorities appear to be Transport for NSW (repair of the groyne) and Randwick City Council (ensuring safe beach conditions for swimmers and surfers).

The Precinct requests its executive write to Transport for NSW, General Manager Randwick City Council and Local Member of State Parliament Michael Daley, requesting they take action to rectify this situation.

**Resolution 27112024(1):** Bays and Beaches Precinct requests Randwick City Council investigate, as a matter of urgency, the reduction in height or removal of vegetation on the south side of Little Bay Road in the vicinity of the Bunnerong Road roundabout — to improve visibility for vehicles northbound on Bunnerong Road.

#### **Council response**

Thank you for your email.

Council Officers have inspected the garden beds located at the southeastern corner of Little Bay Road and Bunnerong Road, Chifley.

Images have been attached in relation to the area inspected for your reference.

Based upon the specifics of the request and focusing upon the north bound traffic flow, the current garden beds, and existing planting heights and densities located in proximity of the roundabout do not present as encroaching upon lines of sight.

Council is of the opinion that there is adequate visibility at the intersection allowing for safe passage, these garden beds are regularly maintained and shaped to be low profile and of moderate height. Some vegetation in this location improves road safety as motorists will slow down on the approach to the intersection, rather than coming into the intersection at high speed.

Thank you for your letter on behalf of Mr Peter Fagan and Mr Chris Hanson of the Bays and Beaches Precinct regarding public access roads in Kamay Botany Bay National Park.

The National Parks and Wildlife Service (NPWS) is aware of a number of the issues raised by your constituents in relation to these roads and have been working with Randwick City Council on this matter. Council traffic engineers have been engaged to undertake a risk assessment of Henry Head Lane and Cape Banks Road. Actions identified will be prioritised and form part of an ongoing maintenance plan.

As these roads are Crown roads, it is the responsibility of all road users to maintain them. In this case, the road users include NSW Golf Club, St Micheal's Golf Club, Westpac Life Saver Rescue Helicopter Base, Sydney Pistol Club and the National Parks and Wildlife Service (NPWS).

NPWS will work with all road users to ensure basic road and vegetation maintenance is completed for the safety of all visitors to the national park. NPWS compliance officers will also address any illegal parking issues along Henry Head Lane.




## Molineaux Point break wall protects Brotherson Dock and Bulk Liquid Berths — but redirects powerful swells onto Yarra Bay












The groyne was strongly constructed. From high water mark it is shielded by tightly packed and interlocking <u>dolosse</u>.




### Beneath the dolosse is a core of layers of dolerite, graded for size




## Above high water mark, instead of dolosse, large dolerite boulders were carefully placed




## Wave action over the years has breached the integrity of the groyne




#### Area of damage (left of "Yarra Bay Beach" label)







### Dolosse and dolerite pieces large and small are being scattered

Dolosse and dolerite pieces are being buried. They are hazards to swimmers and surfers.



#### What are the risks?

If the groyne continues to disintegrate and is eventually pierced:

 Sailing club house, rigging area, launching ramp and beach will lose protection from big swells


Whose insurer will pay for the storm damage?

- Dolosse and rock will spread south east and north west, placing surfers and swimmers at risk of:
  - head and body injuries from collisions with dolosse and rock
  - cuts from rusting steel reinforcement (exposed as dolosse disintegrate)

These personal injury risks will necessitate permanent closure of the impacted lengths of the beach

Delaying repair will increase the risks and the cost of eventual repair

Disintegration of the groyne will make the lengths of Yarra Bay beach marked in red unsafe for swimmers and surfers. These areas will need to be permanently closed.

Who was responsible for installing the groyne?

Who paid for it?

Who owns it?

Who is responsible for ongoing maintenance?

Do the owners have a responsibility to get it repaired?

Who should pay for the repair and debris cleanup?

If there is no repair, who will accept responsibility for the risks?
