| 7. Business arising | Ray Brownlee – GM Randwick council – Q and A |
| | Spoke about Closure Raymond Ave and MacCauley St – forcing trucks to head southward to Botany Road- this will be recommended to traffic committee in December. If approved this may take a few months to have it implemented. Bunnerong Road – Matraville Business Centre – work will commence again in March 2025. Smaller sections will be take place. Residents commented: |

Entrance to Matraville is very poor visually, Cnr Beauchamp and Bunnerong, could be given up an upgrade to brighten the entrance to the township can this be increased.

Matraville Youth Centre – a form will need to be completed if using the park land separate from the hall. Trees will be planted to provide some privacy. Current arrangements of hiring hall be reviewed in - MAY 2025. Usage of Matraville Youth Centre is residents 68% local and 32% aren't local.

Residents raised – issues drinking alcohol and smoking, outside of hall, Children playing in the grass parkland. Place a hall manager in place to report on the usage of the hall. Ray advised – rangers are patrolling the hall area and have advised no anti-social activity.

Council trying to tighten the rules of what is the grounds can be used by.

Bill Burst raised to Ray GM– suggested that a moratorium be put in placed on hire of the hall.

Daunt Avenue development – issues raised – damage to pathway, traffic issues blocking road. Resident raised the issue of challenging the DA of 54 Daunt Ave, the resident felt that she was dismissed by the panel on site after the appealing the DA decision.

Ray advised that he talk to the resident offline to chat on issues experienced.

Resident mentioned ANZAC parade – parking in median strip between Duffy's corner to Little Bay.

Ray advised – that this is being raised in November council meeting.
