Resolution 05032025(3): Security Improvement – Moved that Randwick Council include security measures for the Cenotaph in High Cross Park in conjunction with upgrades to security for the Captain Cook Statue.

Council response

In February 2025, following a second significant incident of vandalism to the Captain Cook Statue on the corner of Avoca Street and Belmore Rd, Randwick, Council installed CCTV as an additional security measure to cover an identified gap and aid any future NSW Police investigation.

The damage caused by the vandalism to the Captain Cook Statue resulted in significant costs being incurred by Council to repair the statue.

Council has not been made aware of any similar such incidents that have occurred to the Cenotaph in High Cross Park that require the installation of new security infrastructure.

Council will continue to liaise with NSW Police to identify specific areas across the LGA that could benefit from additional CCTV, however Councils response is always balanced against the ongoing risk, whether there are third party security systems that already provide coverage (such as TfNSW cameras), the perceived effectiveness of any proposed solution and community privacy concerns.

Resolution 05032025(4): Moved that Randwick Precinct supports the use of Sandgate Cottage as a community space which will also help activate Belmore Rd and Randwick Junction.

Council response and contact

Thank you for the Resolution and consideration of the future use of Sandgate Cottage for community and alternative use.

Council presented a report to the 29 April 2025 Council meeting, investigating the current and potential uses of the building and taking into account Council's current and significant commitment to repurposing other heritage venues in the current and upcoming years. Whilst Sandgate has many strong attributes in terms of location, visibility and heritage character, a change of use in the shorter term was not recommended due to resourcing, expected significant capital and remedial works, and cultural capital commitments.

Council supported this recommendation, and we will be looking at developing a longer term use for Sandgate whilst also exploring ways to activate the front courtyard (June Moore Place) to contribute to the vibrancy of the area and to enliven the main street, through our arts and culture and economic development teams in the near future.
