Email sent to Precinct: Thank you for your feedback regarding the recent works at the southern end of Stage 2 of the Matraville Business Upgrade project., , Council acknowledges the concerns raised about the quality and finish of the works, particularly the rubber matting outside the pub and the road gutter alignment near the bus entrance. These issues were identified during construction and have been subject to regular site inspections. On the 8 October 2025, the kerb levels were completed in accordance with the approved design, and the soft fall treatment outside the pub was revised to accommodate operational needs, including the delivery of beer kegs., , Regarding the approval process, Council follows a structured inspection approval process. Any non-compliant or damaged works are rectified by the contractor as part of this process., , In relation to the comparison with Maroubra, the materials used in each town centre are determined by Council's Town Centre Strategic Asset Plans. These plans consider site specific conditions, functional requirements, and broader urban design strategies. Residents feel that there is an increase in the number of these utilities parked in front of parks and pedestrian crossing. E.g. Menin Road Matraville caravan parked in front of pedestrian crossing., 1. Duration a Vehicle May Remain on a Public Road Before Being Considered Unattended, Under the PSUP Act 2021, a registered and legally parked Class 3 item—which includes motor vehicles/trailers and caravans —may remain on a public road for a continuous period of up to 28 days before it can be subject to regulatory action on the grounds of being "unattended.", If a vehicle remains stationary beyond this timeframe without lawful authority or evident purpose, enforcement processes under the PSUP Act may be initiated. Importantly, where regulatory action is proposed, the Act provides a statutory notice period of 15 days, allowing the owner time to respond or remove the vehicle prior to any formal action being taken., 2. NSW Road Rule 172 – Stopping Near Pedestrian Crossings, NSW Road Rule 172 states:, A driver must not stop on a pedestrian crossing that is not at an intersection, or on the road within 20 metres before and 10 metres after the crossing—unless the location is regulated by a parking control sign that explicitly permits stopping., This rule is in place to protect pedestrian safety and maintain clear sightlines. Vehicles stopping or parking within these distances without appropriate signage are in breach of the Road Rules and may be subject to penalties regardless of how long they are parked., Council Rangers have undertaken patrols of Menin Road and have not observed any illegal parking activity, however, should you have specific vehicles of concern, please do not hesitate to contact us and we will investigate accordingly., Please let us know if you need further clarification or assistance.

<p>Dear Matraville Precinct Committee,, I refer to Resolution 14072025(2) (Item Number: 150518/25) , RESOLUTION (Committee) Double B's still continue to use Bunnerong Road as their main route for heading north and south. Can council investigate placing cameras on Bunnerong Road to gauge the length of trucks that continue to use Bunnerong Road illegally., Council Officer Response, Council is aware that in July 2024 TfNSW began deploying artificial intelligence-enabled technology to analyse freight vehicles to help in assisting supply chain decisions that reduce congestion and lead to enhanced productivity (Please see attached fact sheet)., Under the program high-definition images of heavy vehicles are taken by the cameras which are then then classified into the type of vehicle in transit and the type of cargo being transported. This information will enable TfNSW to better understand freight movements, vehicle configuration trends and network usage across the state with the aim of assisting in long-term planning for the movement of goods in NSW. , This is a new technology and is currently being tested. The accuracy of the system is currently dependent on Transport for NSW manually classifying and training the artificial intelligence-enabled technology., On this basis the cameras are not used for enforcement. However, once the technology is proven this may be a feature that becomes available in the future., Council will follow the development of this technology with interest to identify whether any local practical applications of the technology may be considered in the future., Existing Restrictions, Under the NHVR the current restrictions exist on Bunnerong Road between Wentworth Avenue and Botany Rd, Matraville., The driver of a defined heavy vehicle (in excess of 12.5m in length) is permitted to travel from Port Botany to a destination on Beauchamp Road, Matraville, despite "No Trucks" restrictions on Bunnerong Road at Matraville (Road Rule 104) and to make a left turn from Wentworth Avenue into Denison Road at Eastgardens, despite a no left turn sign (Road Rule 91). , , Should you require further information, please do not heistate to contact me.</p>
