Bays and Beaches Precinct requests Council to provide dog waste bag stations at the following locations at Chifley Reserve:

- 1. Bunnerong Road car park, top of stairs leading up from the carpark.
- 2. Outside children's playground
- 3. Beside large RCC sign on path leading to Hastings Street

We also request Council to:

- 1. Investigate other sites in South Ward that need dog waste stations
- 2. Conduct roving Ranger patrols to enforce the picking up of dog waste by owners and
- 3. Encourage the picking up of dog waste by owners through Council publicity such as email newsletters and Council web site

## **Council response:**

Council installs dog waste bag dispensers at off-leash dog parks only. The reasons include:

- Community members are taking multiple dog waste bags to avoid purchasing them.
- The restocking of the dog waste bag dispensers requires staff resourcing.
- The presence of dog waste bag dispensers gives the impression that the open space if an off-leash dog park.

On this basis, the request for dog waste dispensers at Chifley Sports Reserve is not supported.

I have spoken with council's Ranger Services about additional patrols to enforce dog owners picking up after their dogs. The Manager has advised that they already undertake patrols across the LGA and undertake enforcement where possible. Please note that it can be very

challenging to undertaken enforcement of owners not picking up after their dog.

I thank you for the suggestion to include educational material about dog ownership in our newsletters and publications. I have requested our Communications team to include such material in future publications.

### **Council response:**

Council officers currently have a suite of documents for management of trees including Tree Policies, A Register of Significant Trees, Street Tree Masterplan and Tree Management Technical Manual.

Based on current resources and lack of data, we have been unable to develop proactive maintenance programs.

However, we recently completed a survey of all our street trees to capture information on the number of trees, their species, size, condition and remaining useful life. This data has been useful in allowing us to better manage our tree maintenance and planting programs.

The new Urban Forest Planner role is more strategically focused and will oversee the review of current policies, practices and processes. As part of this work, we will review our tree maintenance requirements against our current resources with a view to a more proactive maintenance approach.

Councillor Bill Burst said there are plans afoot to have an outdoor gym and new toilets and amenities constructed near the children's playground on Pine Avenue. This proposal is now included in the 2024/25 draft plan.

Bays & Beaches Precinct supports Council's initiative and requests Council to consult with the PHCA and local community on the location and design of such a facility to ensure that it aligns with the Prince Henry Master Plan.

#### **Council response:**

Council has allocated funding in the 2024-25 Capital Works program for amenities at Little Bay. The planning for these facilities will be undertaken in consultation with key stakeholders, particularly the Prince Henry Community Association.

In relation to the outdoor gym, at its meeting held in March 2024, council resolved as follows:

There is no funding in the current capital works budget for an outdoor gym at this location. The investigation will consider the number of outdoor gyms in each ward and across the LGA and whether it is feasible to install an outdoor gym at this location.
