# **TERMS AND CONDITIONS**

#### 1. STANDARD TERMS

By entering the Randwick City Council Christmas World Scramble Competition you are agreeing to the following terms and conditions:

#### 2. ENTRY

- 2.1 Entry is open to all residents in Australia.
- 2.2 Employees, contractors and their immediate families of Randwick City Council may enter but are not eligible to win prizes. The 12 letters can be found by following each QR code located on 12 presents along the Coogee to Clovelly Coastal Walkway.
- 3.3 Multiple entries from the same person will not be accepted.
- 3.4 The winner must submit their real name and details. Fake or fictious names and addresses will not be eligible to win.
- 3.5 Randwick City Council will not be liable for any late, lost or misdirected entries.
- 3.6 Incomplete, incorrect or incomprehensible details will, at the sole and absolute discretion of Randwick City Council, invalidate the participant's entry into the Competition.

- 5.4 Randwick City Council reserves the right to verify the validity of entries and to disqualify any entry which, in the opinion of Council, includes objectionable content, profanity, potentially insulting, inflammatory or defamatory statements,









disqualify any entrant who tampers with the entry process, who submits an entry that is not in accordance with these terms and conditions of entry, or who has, in the opinion of Council, engaged in conduct in entering the promotion which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the promotion and/or Council. Council reserves the right to disqualify a winner if Council becomes aware that the winner and/or the winner's entry is of a type described in this clause.
