5. Matters Arising:

6. Presentation:

The Draft Urban Forest Policy- presentation on the policy and other tree related issues by Kara Taylor, Manager Sustainability and Resilience and Julian Lee, Sustainability Coordinator.

Kara and Julian outlined the Policy's main aims, of improving local biodiversity, reducing urban heat, and supporting water-sensitive design. It is an important component of the Council's Resilience Strategy. They will be providing further detail with the production of the Randwick Tree Master Plan, the Register of Significant Trees.

The policy identifies the tree canopy target of 22% by 2040. That is 6% up from the 2022 canopy survey finding of 16% cover in Randwick. The reasons for the lower target related to the following factors:

- ➤ The Council has limited control over tree coverage on private land.
- Tree planting is limited or not possible when there are other uses on public land, such as sporting fields or spaces such as national parks where Council has no control.
- ➤ There is a high cost associated with the planting and maintenance of trees. For 6,000 trees it cost approximately \$2,000,000 for planting and maintenance.
- ➤ The Council has a limited control over private land usage for tree planting.
- ➤ The 22% target was revised down from the previous 36% target by 2035 as being more achievable due to the above factors. It was developed by looking at what similar councils had determined for their areas of responsibility. It does not mean that a higher level could not be achieved.
- ➤ Residents are able to request a tree from Council who will come to the property and plant it.
- Although Centennial Park is in the Randwick boundary it is managed by the Centennial Park and Moore Park trust, an agency of the NSW Government's Office of Environment and Heritage.

Comments and questions from the members were:

- Has an interim target been considered as 2040 is a relatively long way off? No interim target has been developed, to date.
- What constitutes a tree for the purposes of canopy? A tree must be at least 3 metres tall and acceptable as a species for the Randwick area.
- How and how often will progress toward the target be assessed and who will receive the report?
- Are there areas, not currently covered with trees, that have been identified that can be used for tree planting, and can we nominate an area we think would be appropriate?
- What consideration is given to promoting indigenous flora by the type of trees being planted?
- Is there research on the original flora of the Clovelly area which can guide the choice of trees planted now?
- When will the of Randwick Street Master Plan and the Register of Significant Trees be completed?

At the end of the presentation and questions, Bill tabled an email he had received from a local resident about a notice pinned to a tree on the verge in Fern Street, notifying its imminent removal. The notice stated:

As part of the development of this property Council wishes to advise that this tree has been scheduled for removal.

The tree will be removed within approximately four weeks A replacement planting will be arranged at the completion of the construction

Her concerns were that it was a substantial street tree and though she had written to the Council as offered in the notice had not received a response. Kara and lee took the details and said that they would follow it up and get back to the committee.

thanked Kara and Julian very much and hoped to follow up with them on progress on this very important endeavour.
