**NOTES**

Food business notification:

All food businesses in NSW must either:

- Hold a current NSW Food Authority licence (this applies only to specific food businesses in sectors covered by a Regulation under the *NSW Food Act 2003*); or
- Notify Randwick City Council of their food activity details. This applies to almost all other food businesses and includes those involved in temporary events and businesses which sell any sort of food or food ingredient as any part of their business. It is required by national food law (Food Safety Standard 3.2.2)

The only exceptions to either of the above are for not-for-profit fundraising events, which are not required to notify.

As well as notification, all food businesses must comply with the relevant food standards (see NSW food business legislation and standards for more information)

Inspection of premises:

Council's Environmental Health Officers carry out inspections of food premises from time-to-time, to check compliance with relevant food safety requirements and standards. After carrying out an inspection, an invoice will be forwarded for payment, in accordance with Council's Pricing Policy.

Food Safety Requirements:

The design, construction and the ongoing operation of all food premises must comply with the relevant requirements of the *Food Act 2003*, *Food Regulation 2010* and the Australian and New Zealand Food Authority (ANZFA) Food Safety Standards at all times.

Failure to comply with these requirements is an offence and which may result in the issue of a Food Improvement Notice, Prohibition Order, Penalty Notice (fine) or Court Proceedings.
